Financial Services Deputy Director Social Services Agency



Alameda County Social Services Agency is recruiting to fill one vacancy for the position of Financial Services Deputy Director. This position is responsible for managing the budget and accounting teams within the Social Services Agency. This includes planning and managing the Agency's budget development and budget management processes, including accounting, claim reimbursement, distribution of assistance payments to clients, revenue maximization efforts and other related work as required. The Financial Services Deputy Director reports directly to the Financial Services Director and acts as "second-in-charge" within the Finance Department.

The Social Services Agency consists of the following four departments whose mandated services include:

- Workforce and Benefits Administration administers the eligibility and disbursement of mandated assistance programs and provides the required employment and support services for public assistance recipients.
- Children and Family Services provide emergency response and shelter services as well as investigative, maintenance, reunification, and permanent placement services and administer the Foster Care Program.
- Adult, Aging and Medi-Cal Services (AAMS) provides Adult Protective, Public Guardian/ Conservator/Administrator, and Older American/Californian Acts services. AAMS also administers in Home Supportive Services (IHSS), Regular Medi-Cal and Long Term Care programs and operates the Area on Aging and Veteran Services Office.
- Administration and Finance provides support to Agency departments and staff through various administrative areas such as Information Technology and Services, Human Resources and Training, Finance and General Accounting and general Office Support Services.

MINIMUM QUALIFICATIONS INCLUDE:

The equivalent of five years of responsible financial and/or budget management experience two years of which required considerable independent judgment in financial policy development and interpretation. Possession of a bachelor's degree from an accredited college or university with a degree in accounting; business administration, public administration, or a closely related field may be substituted for one year of experience. Possession of a Master's degree in business administration, or a closely related field may be substituted for two years of experience.

THE IDEAL CANDIDATE

In addition to meeting the minimum qualifications, the Financial Services Deputy Director will have a solid history of:

- **Budget Forecasting**, including developing models or projections based on studying past results, relationships, and data and anticipating future trends/events.
- **Understanding fiscal impacts** of legislation and state memoranda related to state and county allocation formulas.
- **Planning and Organizing**, including managing several tasks at once and establishing a course of action for self and others to ensure that work is completed efficiently.
- Researching, compiling and summarizing varied information, evaluating alternatives and **reaching sound conclusions**.
- Effectively implementing management principles and practices when providing employee supervision. Effectively plan, supervise, review and evaluate the work of others either directly or through subordinate supervision.
- Accomplish Work Objectives, by leading and guiding a team of employees through establishing development plans, setting performance goals, and tracking and evaluating performance.
- Communicating effectively, including the ability to write complex technical reports and conduct effect meetings. Represent the department and the County in meetings with others.
- **Performing as a strong collaborator**, adept in identifying opportunities and taking action to build strategic relationships to help achieve agency goals. Build effective collaborative environments with internal and external stakeholders.
- Maintaining Stable Performance in situations where there may be opposition and/or pressures. Maintain focus on work tasks and develop appropriate strategies to cope effectively with stresses.

- Describe your experience leading financial analysts and/or accountants in a large organization comparable to the Alameda County Social Services Agency. Tell us about your team. What was your role? Describe a challenge you faced with the team and how you handled it.
- 2. Describe your experience leading a team that forecasts expenses and revenues in an agency comparable to the Alameda County Social Services Agency. Please describe how the results of your team's work was used.
- 3. Describe your experience where you exercised independent judgment in financial policy development and interpretation.
- 4. Describe your experience overseeing work to claim state and federal revenue for an organization comparable to the Alameda County Social Services Agency.
- 5. Describe a specific example in which you managed the financial aspects of a new program implementation.
