## **GSA's Technical Services Department**

The current vacancy is located in GSA's Technical Services Department. The Technical Services Department is responsible for cost effective, timely, management of Capital Construction projects with an annual budget of more than \$500 million, including medical facilities construction management. The Technical Services Department is also responsible for energy management, environmental and hazardous materials management, sustainability, and property and salvage.

Under administrative direction of the Director or the Assistant Director of the General Services Agency, the Deputy Director, GSA plans, organizes, coordinates and directs the operation of the Technical Services Department of the General Services Agency. Additionally, the Deputy Director for the Technical Services Department is responsible for architectural and construction services, energy management, environmental and hazard-ous materials management, sustainability programs, medical facilities construction, property and salvage and related professional engineering services for all County buildings and building systems.

## **Alameda County**

Alameda County with a population approaching 1.6 million residents is the geographic center of the San Francisco Bay Area, located on the east side of the Bay across from the San Francisco peninsula, with Contra Costa County to the north and Santa Clara County to the south.

Alameda is the second largest county in the Bay Area and the seventh largest county in the State. ## The Process

THE EXAMINATION WILL CONSIST OF the following steps:

- 1) A review of candidates' applications to verify possession of minimum requirements. Those candidates who possess the minimum requirements for the class will move on to the next step in the examination process.
- 2) A review of candidates' Supplemental Questionnaires (SQ) to select the best qualified applicants to continue in the process.
- 3) An oral interview which will be weighted as 100% of the candidate's final examination score. The oral interview may contain situational exercises.
