Regional Disaster Medical Health Specialist

The San Joaquin County Emergency Medical Services Agency is seeking a Regional Disaster Medical Health Specialist to facilitate coordination between various local, regional, and state agencies that provide emergency medical and disaster services to Regional IV Multi-Casualty Incident Plan and Medical Health Mutual Aid System.

Typical duties include

- ◆ Coordinates, develops and implements regional disaster medical-health related response, operations and recovery plans for Region IV; updates and revises plans necessary to meet changes in laws and regulations.
- ◆ Prepares and conducts exercises to test mutual aid plans and procedures with operational area participants; designs and conducts tests of state, regional, and local coordination of emergency plans.
- ◆ Coordinates medical-health mutual aid response in support of other state regions and within county jurisdiction, as directed.
- ◆ Prepares narrative and statistical reports and correspondence in response to local, regional and state authorities.
- ◆ Provides advice and assistance to counties in implementing regional disaster and/or emergency plans, policies, and procedures; may provide training as directed.
- ◆ Reviews, interprets, and implements current, revised, or new local, regional, and/or state regulations, policies, and procedures.
- ◆ Attends conference and meetings to represent local, regional, and state emergency health needs; plans, organizes, and conducts meetings with representatives from Region IV counties.

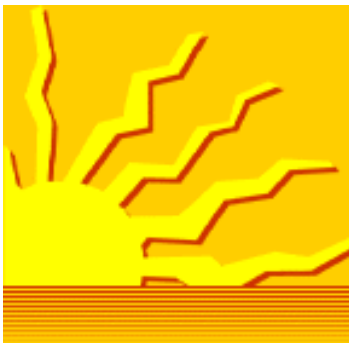
MINIMUM QUALIFICATIONS

Emergency Medical Services Agency About the Department

The Board of Supervisors created the San Joaquin County EMS Agency under authority of the California EMS Act to plan, implement, and evaluate the emergency medical services system, consisting of an organized pattern of readiness and response services based on public and private agreements and operational procedures.

The EMS Agency provides medical control of the EMS system and serves as the lead on all Continuous Quality Improvement (CQI) activities throughout the EMS system. The EMS Agency approves dispatch, provider and hospital CQI programs, leading peer-to-peer CQI activities, manages individual and provider performance improvement plans and investigates citizen complaints, unusual occurrences, and EMS personnel formal investigations.

The EMS Agency maintains an on-call EMS Duty Officer 24 hours a day/ seven days a week to respond to mutual aid requests; coordinate disaster medical operations and to assist hospitals and providers in managing the EMS system. The on-call EMS Duty Officer also serves as the medical health operational area coordinator designee under the direction of the EMS Administrator.
