PUBLIC HEALTH SERVICES

The Public Health Services campus is located in Stockton, CA. The health department provides a culturally diverse community (685,660) with classic public health services. The Department has a tradition of strong community involvement and leadership in health promotion. Within Public Health Services, programs are administered through the Family Health and Disease Control and Prevention Division.



THE POSITION

There is currently one **Assistant Health Officer** vacancy to support programs in the Public Health Services Family Health Division, which include: California Children's Services, CHDP, Childhood Lead Poisoning Prevention, Child Passenger Safety, Adolescent Programs, WIC, PHN Home Visiting and Maternal & Child Health programs. The primary duties of the Assistant Health Officer within the California Children's Services will be to develop program policies, provide medical consultation, direction, and oversight of the program's skilled professional medical personnel.



TYPICAL DUTIES

- ◆ Provides training for CCS professional medical personnel including contracted physicians.
- ◆ Serves as liaison with State medical consultants and with medical directors of other agencies.
- ◆ Acts in State required capacities as defined in State law and regulations pertaining to CCS.
- ◆ Consults with Medical Therapy Unit (MTU) by consulting with the supervising therapists in case management of complex cases and attending MTU conferences with physician specialists and MTU staff.
- ◆ With CCS & MTU management provides utilization review and quality improvement services for CCS medical case management functions, medical therapy conferences and direct therapy services.
- ◆ Provides leadership to Maternal Child and Adolescent Health projects such as Child Death Review, Fetal and Infant Mortality Review, Childhood Lead Poisoning Program and Child Health Disability Prevention.
- ◆ Participates in assessment of local community health indicators in maternal, child and adolescent health and chronic diseases and other issues of public health significance; works with local health providers and community groups to plan, implement and evaluate strategies to improve community health.
- ◆ May assist in planning, organizing, coordinating and responding to public health emergencies.
- ◆ May, on occasion, provide patient care and medical oversight to mid-level practitioners in the Public Health Services Clinic.
- ◆ Represents and promotes the activities of Public Health Services through participation on coalitions and committees at both the local and state levels; makes presentations; responds to media inquiries and writes material for public release.
- ◆ May serve as Health Officer in the Health Officer's absence or perform other duties as assigned.

Substitution: A master's degree in public health (MPH) is desirable and may be substituted for one year of the required experience as a licensed physician. Board certification in General Preventive Medicine/Public Health is strongly desired and may substitute for two years of experience in public health practice.

San Joaquin County offers a competitive compensation package

Annual Base Salary: \$134,014-\$162,885

In addition to base salary, the County offers:

- ◆ **Cafeteria Plan:** \$23,265 annual amount which may be used to purchase medical, dental, and vision coverage. Unused monies are included in salary. The entire cafeteria amount is considered earnings and is added to the base salary when calculating retirement benefits.
- ◆ A 2% employer contribution to the County's 457 Deferred Compensation Plan.
- ◆ Vacation cash-out up to 8 days annually (valued from \$4,124 to \$5,012).
