# **THE POSITION**

This middle management position reports to the Director of Mary Graham Children's Shelter and is responsible to assist in the management of the daily operations of the Mary Graham Children's Shelter (MGCS). Of 54 total allocated positions to MGCS,11 Shelter Supervisors and 30 Shelter Counselors provide direct care and supervision of children brought to the shelter. Administrative and office support, housekeeping and maintenance staff comprise the rest. Typical duties include the following:

- Supervises personnel including subordinate supervisors, in the daily operations, programs and activities of the children's shelter and satellite programs.
- Assists the Director in recruiting, hiring, assigning, delegating, supervising and evaluating shelter staff; plans and conducts staff meetings, directs and develops staff orientations and staff development training programs.
- Communicates and collaborates with other service providers; nurtures working relationships with community groups and volunteer organizations on behalf of the Director; assists in developing and coordinating community involvement programs involving direct and indirect services, meets with individuals and groups interested in shelter programs.
- Maintains liaison with school officials, social service case workers, child welfare supervisors, mental health clinicians and consultants and public health personnel regarding information affecting the problems and adjustment of children in the shelter.
- Supervises and assists in the admission and release of children, provides direction and assistance to shelter counselors regarding the safety and supervision of children with special needs; in emergency situations, may counsel children
- Prepares correspondence and reports; assists in preparing budget reports.

#### COMPENSATION PACKAGE

#### Annual Base Salary: \$75,337 to \$91,603

### MINIMUM QUALIFICATIONS

NOTE: Supplemental Questions must be turned in with employment application.

#### **EITHER**

**Education:** Graduation from an accredited four-year college or university with a major in social or behavioral sciences, business or public administration, or a closely related field.

**Experience:** Five years performing social services work for children and their families, including at least three years as a supervisor.

**Substitutions:** 1) A master's degree in social work, psychology, sociology, criminal justice, child development, public administration, business administration or related field may be substituted for one year of the required <u>non</u>-supervisory social work experience; <u>OR</u> 2) experience performing social services work for adults may be substituted, on a year-for-year basis, for up to two years of the required non-supervisory children's social work experience; <u>OR</u> 3) experience performing professional personnel, fiscal, or similar administrative duties in a shelter, group home, or similar residential setting may be substituted, on a year-for-year basis, for up to two years of the required <u>non-supervisory</u> children's social services work experience; <u>AND</u> 4) one year of experience <u>supervising</u> personnel, fiscal, or related administrative staff and functions in a shelter, group home, or similar residential setting may be substituted for one year of the required <u>supervisory</u> experience.

**Experience:** One year as a Shelter Supervisor II in San Joaquin County.

#### <u> 0R</u>

**Experience:** Three years as a Shelter Supervisor I in San Joaquin County.

#### AND

License: Possession of a valid California driver's license.

<u>Certificates:</u> Must become certified in Basic First Aid and Cardiopulmonary Resuscitation (CPR) within the first six months of employment and maintain such certification during employment.

**Special Requirement**: Must pass fingerprinting and/or other background processes as required by state law.

This is an important part of your application package that will allow us to thoroughly assess and evaluate your qualifications for the position of Assistant Director - Mary Graham Children's Shelter.

1. Describe your experience performing social services work for children and their families.

2. Do you have experience working in a county temporary shelter? If so, describe your role and responsibilities.

3. Describe three years experience as a supervisor, performing social services work for children and their families. Include in your response the types of programs you supervise and an organizational chart showing the job titles of those that report to you and the job titles of those to whom you report.

4. Describe your experience establishing partnerships with service providers in the community as it relates to children's shelters. Include how you maintain ongoing collaboration with service providers.

5. Explain what you believe to be the two most critical issues facing county temporary shelters in the next five years.

6. Describe your experience evaluating the effectiveness of temporary shelter programs. Include your role and responsibilities in the evaluation process.
