### San Joaquin General Hospital

San Joaquin General is a 196-bed public teaching hospital with full accreditation by the Joint Commission. It employs 1,700 staff members located in French Camp, California. The hospital offers physician residencies in family medicine, internal medicine, and general surgery. Affiliation exists with the University of California, Davis. The hospital also has a pharmacy residency and is a teaching site for the University of the Pacific School of Pharmacy. Dietetic internship affiliation exists with California State University Sacramento program.

The general acute care facility provides General/Surgical Care, High-Risk Obstetrics and Neonatal Intensive Care, Trauma Care, and Correctional Healthcare. In addition, the medical campus includes multiple facilities dedicated to comprehensive outpatient services, including a dialysis unit, and a full range of diabetes care.
