Exempt Recruitment Announcement: 0814-HC1100-EX San Joaquin County is seeking an experienced public works/engineering professional with strong leadership skills to provide direction for all of the activities of the Public Works Department and to serve as the County Road Commissioner and County Flood Control Engineer. An ideal candidate will possess demonstrated leadership experience and will be knowledgeable in the management of public works operations and public projects. The incumbent is appointed by the Board of Supervisors and is responsible for managing and administering the programs, functions, budgets and activities of the Public Works Department programs. The incumbent is expected to model a strong work ethic and leadership skills, including accountability for oneself and others.

The Public Works Director supervises four direct reports: Deputy Director of Engineering, Deputy Director of Development Services, Deputy Director of Operations, and the Public Works Business Administrator. The department is comprised of 20 operational areas including: Administration, Community Infrastructure-Engineering, Development Services, Engineering Services, Fleet Services, Flood Channel Maintenance, Flood Management, Road Maintenance, Solid Waste Administration, Surveyor, Utility Districts, and Water Resources. The department's operating budget for FY2014-2015 is approximately \$133.8 million and with 374 full-time allocated positions.

THE DEPARTMENT

The Department of Public Works is responsible for planning, designing, constructing, operating, and maintaining public roads, bridges, water, wastewater systems, flood control, and solid waste facilities for the County. In addition, support is provided to various agencies such as the Planning Commission, Board Water Committee, County Advisory Water Commission, Groundwater Basin Authority, Flood Control Technical Advisory Committee, Delta Counties Coalition, and the Delta Coalition.

The overall mission of the department is to protect the health and welfare of the public, preserve the County's infrastructure investments, and develop Countywide long-term plans and programs for transportation systems, water quality and supply needs, flood management interests, and special districts.

The Stockton Symphony, San Joaquin County Ballet, and Stockton Civic Theater provide important experiences for children and adults. The multi-cultural community offers a diversity of views and opinions in its art and culture, providing a wealth of knowledge about past and present on canvas and stage.

Over 75 languages are spoken within the region and there is richness in the blending of cultures and ways that creates an air of celebration about individual customs, foods and cultures.

San Joaquin County government provides nine community parks for boating, camping, picnicking, swimming and organized sports. Annual family events include Stockton's Asparagus Festival, attended by thousands of fun-seekers from the county and beyond, held in downtown Stockton.

Individual cities and communities provide a host of other opportunities. from Lodi Lake Park and Nature Area to the Woodbridge Ecological Reserve. The county-owned and operated Micke Grove Park offers a zoo, rides and a historical museum to delight both children and adults. The San Joaquin Delta is one of the area's best kept secrets and offers some of the best boating in the state: more than 1,000 miles of waterways stretching from the Stockton Harbor north to Sacramento and offering access to the San Francisco Bay.

AGRICULTURE

The county is one of the most agriculturally rich regions in California and is the number one producer, statewide, of asparagus. Twenty-four thousand acres of county farmland are dedicated to production of this crop. In recent years, the leading crop in the county has been wine grapes, and wineries and vineyards have sprung up from Stockton to Lodi.





EDUCATION

From preschool to higher education, the county has it covered with an abundant array of opportunities to learn and grow. The University of the Pacific. California State University, Stanislaus - Stockton Center, Humphreys College and School of Law, National University and San Joaquin Delta Community College offer a wide variety of choices for educational opportunities. The county's 17 school districts provide families with a wide choice for children's educational development.

HOUSING

Homes and apartments are plentiful and the median home price in the county is still affordable when compared to other nearby areas.

Affordable, comfortable housing is available in most sections of the county and new homes abound in both the south and north area, with historic homes found mostly in central Stockton and downtown Lodi.

DIRECTOR OF PUBLIC WORKS

TYPICAL DUTIES

- Plans, organizes, directs, and coordinates the activities of the San Joaquin County Public Works Department, including engineering, surveying, roads, bridges, solid waste operations, transportation, utilities, water resources, flood management, fleet services, and other programs.
- Manages department operations through subordinate management staff; maintains control of assignments of a large and diverse workforce; reviews and mediates personnel problems.
- Oversees the development and implementation of programs and systems which result in efficient and effective public works operations.
- Coordinates County engineering activities and projects with Federal, State, County or related agencies.
- Directs and oversees the County Surveyor function through subordinate staff, or through contracted services.
- Represents the County and confers with officials of Federal, State, and local agencies, and others regarding public works matters of mutual interest for establishing policies, programs, funding initiatives, cooperative agreements and contracts.
- Acts as consultant on technical engineering matters for other County departments.
- Directs and is responsible for the preparation of annual department and special district budgets and ensures that budget expenditures are properly controlled to ensure conformance with approved funding.
- Develops and reviews department policies and programs as required.
- Reviews and analyzes, or directs the review and analysis of the effect of Federal, State, or local legislation on departmental and County operations, and makes appropriate recommendations.

THE IDEAL CANDIDATE

In addition to being a registered Professional Civil Engineer, the ideal candidate will possess:

- A Masters degree in Civil Engineering, Business Administration or Public Administration.
- Demonstrated senior management experience in a public agency performing public works activities.
- Outstanding leadership skills and a strong background managing diverse public works projects and programs.
- Experience as a successful leader and a technical expert.
- Well-developed organizational and decision making skills as well as superb interpersonal skills.
- The ability to inspire, motivate and empower staff in their professional development and to achieve established goals.
- Knowledge of laws and regulations pertaining to the department's programs and initiatives.
- A high level of integrity and strong sense of ethics.
- Strong analytical skills, sound judgment, and a positive attitude.
- Excellent written and verbal communication skills and the ability to synthesize complex information about public works projects for the community and interested parties.
