THE POSITION

The San Joaquin County Public Works Department is seeking a highly experienced, self-motivated leader to join a progressive, public service employer who provides great opportunities for diverse assignments and professional growth. The ideal candidate will have professional engineering experience with a public sector employer in the area of Water Resource Engineering.

Well-qualified candidates will possess exceptional leadership, interpersonal and communication skills, as the position requires frequent interaction and communication with department management, engineering staff, contractors and staff from various County departments.

MINIMUM QUALIFICATIONS

***Experience:** Two years of professional engineering experience in the areas of water resources engineering, wastewater treatment processes, stormwater quality, and/or water law and policy attained post registration as a Civil Engineer.

Education: Must have graduated with a Bachelor's degree in Engineering or a closely related field from a college or university accredited by the Accreditation Board for Engineering Technology.

Licenses & Certificates: Possession of a valid certificate of registration as a Civil Engineer as issued by the California Board of Registration for Professional Engineers and Land Surveyors; and possession of a valid California driver's license are required.

All applications will be reviewed for qualifications. Qualified applicants will be invited to participate in an oral examination interview, with top scoring candidates being referred to the Public Works Department for selection processes.

TYPICAL DUTIES

The Engineer V is a specialized level in the engineering series for San Joaquin County. This position will function as a manager and will be responsible for planning, coordinating, directing and supervising the work of an engineering unit. The incumbent will also support management in areas of personnel, budgeting, planning and policy/procedure development.

The current vacancy is in the Water Resources Division. This position will be involved in water resources planning, groundwater management, and stormwater management.

In addition, the incumbent will be required to:

- ◆ Review and approve plans, specifications and cost estimates for a variety of construction projects; plan and conduct feasibility studies for various projects.
- ◆ Supervise subordinate engineering, administrative and technical personnel.
- ◆ Consult with management and administration regarding the establishment of engineering policies and procedures relating to Water Resource management.
- ◆ Confer with, give technical engineering advice to and supervise engineers in charge of projects; coordinate a variety of projects with other agencies; supervise enforcement of contractual obligations.
- ◆ Prepare ordinances and resolutions regarding their unit area for action by the Board of Supervisors.
- ◆ Assist in the preparation and administration of department budgets, as assigned.
