THE POSITION

San Joaquin County Public Health Services is seeking dynamic and motivated individuals to provide program support for the Health Promotion and Chronic Disease Prevention Unit, Child Health and Disability Prevention Program, and Community Services (HIV/STD) Program.

The Health Promotion and Chronic Disease Prevention Unit works to improve the public's health through programs such as the Breastfeeding Initiative, Child Passenger Safety Program, Nutrition Education Obesity Prevention (NEOP) Program, Public Information and Communication, and the Smoking and Tobacco Outreach/Prevention Program (STOPP). Current and future positions will support chronic disease prevention (e.g., heart disease, stroke, and diabetes prevention) and STOPP (Tobacco Control Program). Each of these programs will focus on promoting changes at the policy, systems and environmental levels to reduce the burden of chronic disease and promote a healthy future in San Joaquin County.

The second position will be responsible for the health education component of the Child Health and Disability Prevention Program (CHDP). The CHDP program is a health promotion and disease prevention program serving infants, children, and teens. Comprehensive, periodic preventative health assessments are provided to eligible infants, children, and teens at no cost. The third position will be in Disease Control and Prevention Division under the Community Services Department. This position will focus on HIV/AIDS/STD education, prevention, counseling, testing, investigations, managing databases, and program planning. This position requires to collaborate with community agencies on issues involving HIV/STD and coordinates program activities with health professionals.

THE DEPARTMENT

The San Joaquin County Public Health Services promotes well-being and prevents disease through community engagement and interaction, education, workforce development, leadership, and strategic planning. The mission of the department is to promote "a healthy future for San Joaquin County".

MINIMUM QUALIFICATIONS

Education: Possession of a Master's Degree in Public Health from an accredited university or college, with a specialization in a public or community health education program accredited by the Council on Education for Public Health.

License: Possession of a valid California driver's license.

TYPICAL DUTIES

The Public Health Educator plans, develops and implements community health education programs and services,

- Coordinates with agency staff to assess and identify community public health educational needs; plans, organizes, implements and evaluates appropriate programs and services designed to meet the educational needs of public and private organizations, schools, community groups and the general public.
- Researches data and prepares copy for various reports, bulletins, periodicals, pamphlets and other written informational and educational presentations; prepares news releases and special features for all news media.
- Informs and interprets to general public, community organizations and other agencies the various services and programs provided by the public health agency; develops a public awareness of general and specific public health needs and problems and practices of general health maintenance, disease prevention and control.
- Plans, conducts and participates in workshops, training sessions, conferences, and other meetings to disseminate accurate public health information; coordinates needs for informational meetings with various agency divisions and staff; trains agency staff in techniques of health education.
- Prepares and delivers presentations to various community and public groups; provides educational liaison between the agency and various interest groups, agencies and schools and assists these organizations in developing internal health education programs.
- Plans, prepares and procures exhibits, posters and various public displays for meetings and conferences.
- Gathers data, prepares appropriate reports, maintains records and prepares correspondence as needed.
- Assists in preparing grant proposals for educational funding; assists in maintaining records and expenditure control.
- May supervise and provide direction and training to staff involved in educational programs.
