# **Public Health Nutritionist**



San Joaquin County Public Health Services is recruiting for dynamic and motivated Public Health Nutritionists to fill current and future vacancies in Public Health Programs. The current vacancy is in the Health Promotion and Chronic Disease Prevention Program, and will support program efforts to increase fruit and vegetable consumption, physical activity, and food security in low-income families, with the goal of preventing obesity and other dietrelated chronic diseases. This Public Health Nutritionist position will oversee the administration of the nutrition education component of the Nutrition Education Obesity Prevention (NEOP) program. This includes the selection of approved education materials, provision of training and technical assistance, and coordination with other agencies that provide complementary programs and services. This position will also provide nutrition education to the SNAP-Ed eligible population. The Public Health Nutritionist will work closely with a team of health educators and other staff to assist with policy, system, and environmental changes in support of obesity prevention, with a focus on our Healthy Retail Recognition Project.

#### **Become a Public Health Nutritionist**

As a **Public Health Nutritionist**, under general supervision, you may assess, plan, develop, and/or implement nutrition-related programs to meet the needs of San Joaquin County residents. This is the entry level of the Public Health Nutritionist series. Employees in this class provide public health nutrition services and as experience and competence are gained, duties are performed with increased independence

#### **Public Health Services**

The Public Health Services campus is located in Stockton, CA. The health department provides a culturally diverse community (685,660) with classic public health services.

# **Public Health Nutritionist**

#### **Typical Duties**

- Develop, implement, and promote nutrition programs and services; interpret and implement federal and state food and nutrition program guidelines; review policies and procedures and make recommendations.
- Develop and implement nutrition education programs for individuals, families and groups; present classes to clients; prepare and evaluate nutrition education materials and interpret its use in local health programs; provide assistance in vendor education.
- Serve as a resource person to agency staff on nutritional problems and issues; coordinate with and assist staff in understanding client needs and carrying out program services.
- Assist in assessing agency needs; may assist in the development of nutrition plans; plan and conduct studies and surveys relating to nutritional status, dietary patterns and food needs of target population groups; gather and analyze data and make program recommendations.
- Within a specified program, may provide breastfeeding support, education and counseling to clients. May prepare and maintain a variety of records and reports; prepare correspondence.
- Attend meetings and conferences; make public presentations; serve as program liaison to community organizations and programs in the area of nutrition and public health.
