



The Medical Therapy Programs of California Children's Services

The Medical Therapy Program (MTP) is a special program within California Children's Services that includes Occupational Therapy (OT) and Physical Therapy (PT) for children birth to 21 years old with eligible conditions including but not limited to: cerebral palsy, spina bifida, and muscular dystrophy. Therapy services are provided at outpatient rehabilitation units located in public schools. These units are called "Medical Therapy Units" (MTU).

THE POSITION

The Physical Therapist-Sr is a case management position that will provide technical and consultation for California Children's Services (CCS) clients and applicants regarding requests for occupational and physical therapy treatment, inpatient rehabilitation, orthotics/prosthetics, and rehabilitation related durable medical equipment as prescribed by the physician and participates in determination of medical eligibility for the Medical Therapy Program in conjunction with the Medical Consultant.

Additional duties include but are not limited to:

- Authorizes CCS services related to PT/OT, durable medical equipment and prosthetics/orthotics. Provides ongoing technical assistance and consultation to medical case management team regarding requests for Occupational/Physical therapy, inpatient rehabilitation, orthotics/prosthetics and rehabilitation related durable medical equipment as prescribed by the physician.
- Attends medical therapy conferences held in the medical therapy units in order to facilitate, collaborate and expedite the equipment needs of the clients.
- Collaborates with MTP staff and defers requests to the medical therapy units as appropriate.
- Develops and implements QA/QI activities with regards to case findings and medical case management of CCS clients in conjunction with the medical case management team and the MTP. Communicates with MTP families as needed for case management purposes.
- Develops a network of OT and PT vendors with experience in treating children with special health care needs.

CALIFORNIA CHILDREN'S SERVICES

CCS is a statewide program that manages, directs and pays for medical care, equipment, and rehabilitation, when these services are authorized by the program. Services can be authorized for children and young adults less than 21 years of age who have eligible medical conditions and whose families are unable to pay for all or part of their care. CCS defines eligibility and selects the most qualified professionals to treat the child's CCS eligible condition.

MINIMUM QUALIFICATIONS

Experience: Two years of progressively responsible experience as a licensed physical therapist performing diagnostic and therapeutic physical therapy techniques for a variety of disabling conditions.

Licenses: Current licensure as a Physical Therapist by the Physical Therapy Board of California (PTBOC) and, if required by the nature of the assignment, possession of valid California driver's license.

Approximate Monthly Salary: \$5666-\$6888
